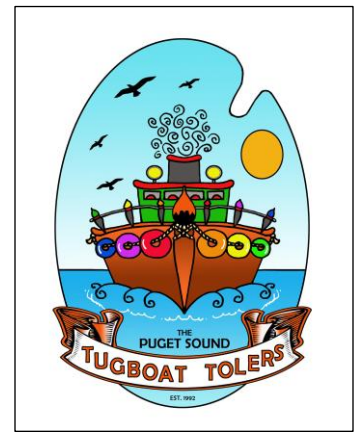

Upon completion of the installation, Monica Bayness, President 2020, made opening statements and welcomed all club members.

### **Committee Reports:**

**Secretary:** 2020 Secretary Patti P. presented minutes from Oct. 5<sup>th</sup> as emailed to board members (copies available at this meeting). A motion by Cyndy M. seconded by Nancy Walch to approve as issued was passed unanimously.

**Hostess:** Karen P. requested members to sign up for one month's hostess responsibility (may be two members as co-chairs). The hostess will be responsible for setting the theme and coordinating the setup/cleanup. Please see Karen. February meeting Hostesses will be Cyndy M. and Helen W. There being no other committee reports, the President recognized Past Vice President Nancy Walch presented a thank you gift to LuAnn W. for our recent year filled with fun and unique leadership.

**New Business:** The following items of new business were discussed for appropriate actions as noted:

- 3) Vicki P. requested approval of payment of a \$500 donation for use of the facility to the church. Motion by Nancy Walch seconded by Karen Pl. to issue check for 2020 facility donation was approved unanimously.

**Adjournment:** There being no further business, the meeting of board and general membership adjourned at 1110 by motion of Monica B. seconded by Janie S. and approved unanimously. The club members then proceeded to lunch and the scheduled paint-in.
